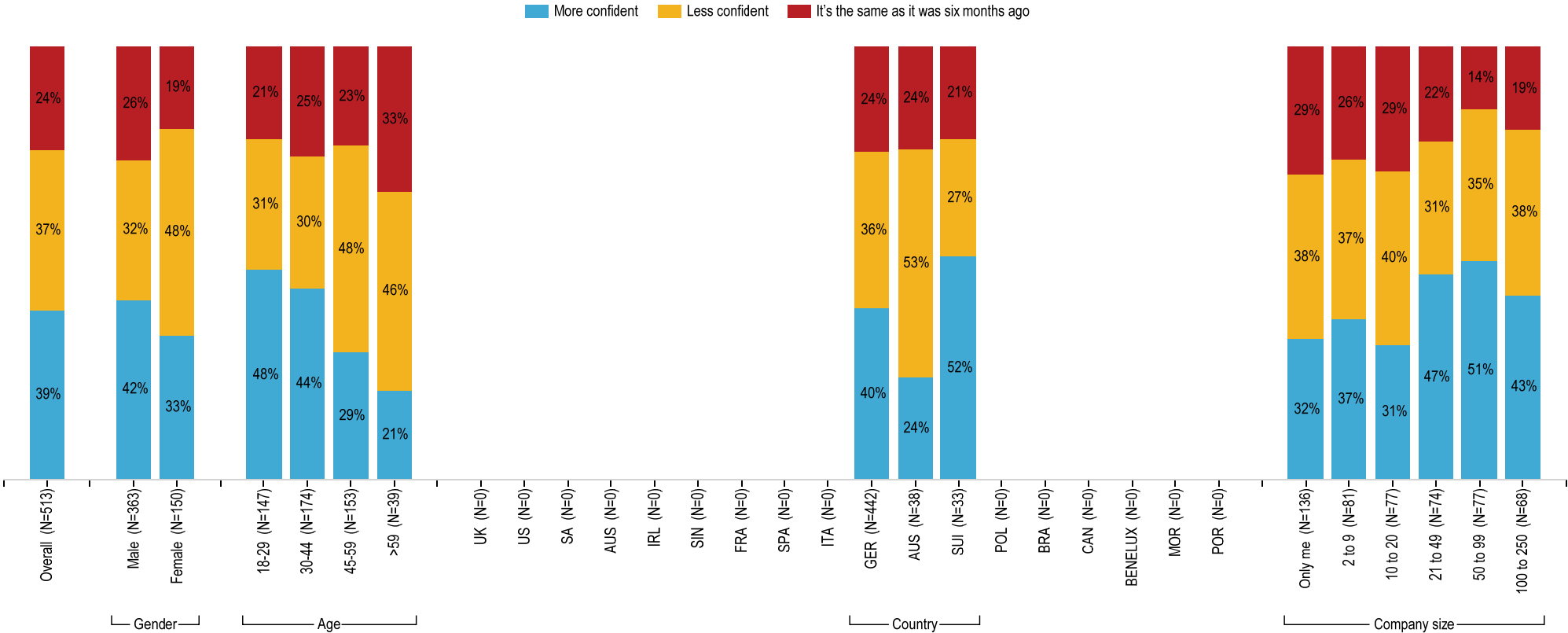
Q5: Feel more or less confident about the prospects for your business in the next six months?



Q5: Consider the global economy to be more or less stable?

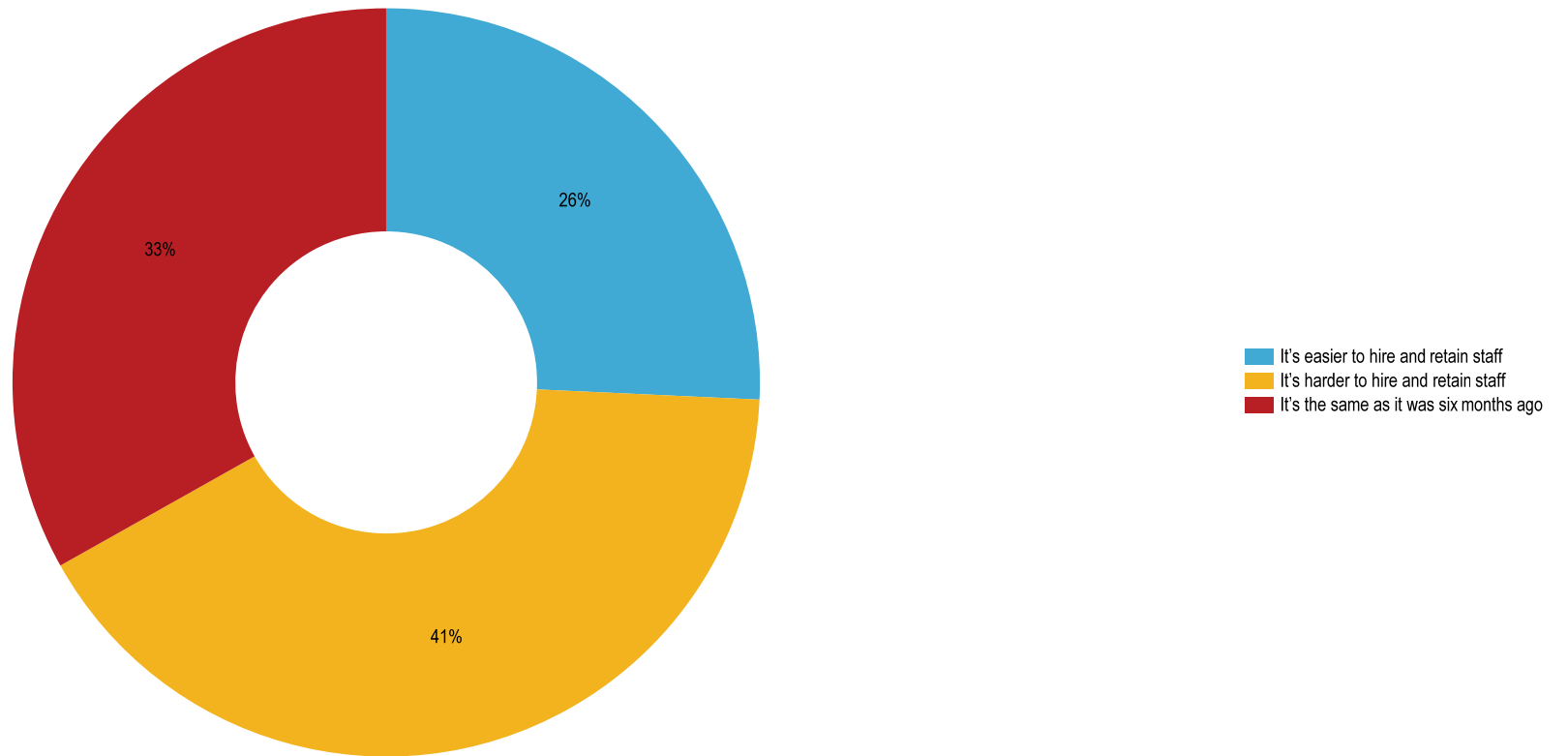


Q5: Consider your country's economy to be more or less stable?



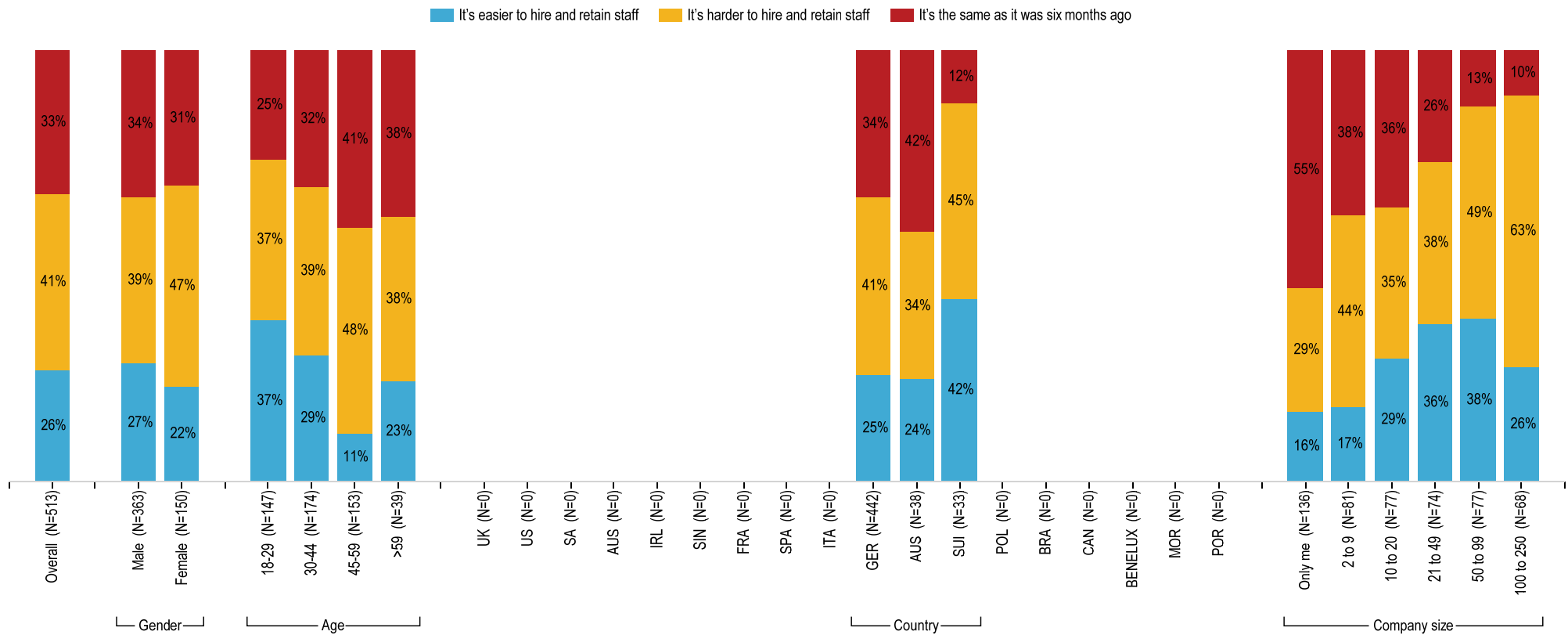

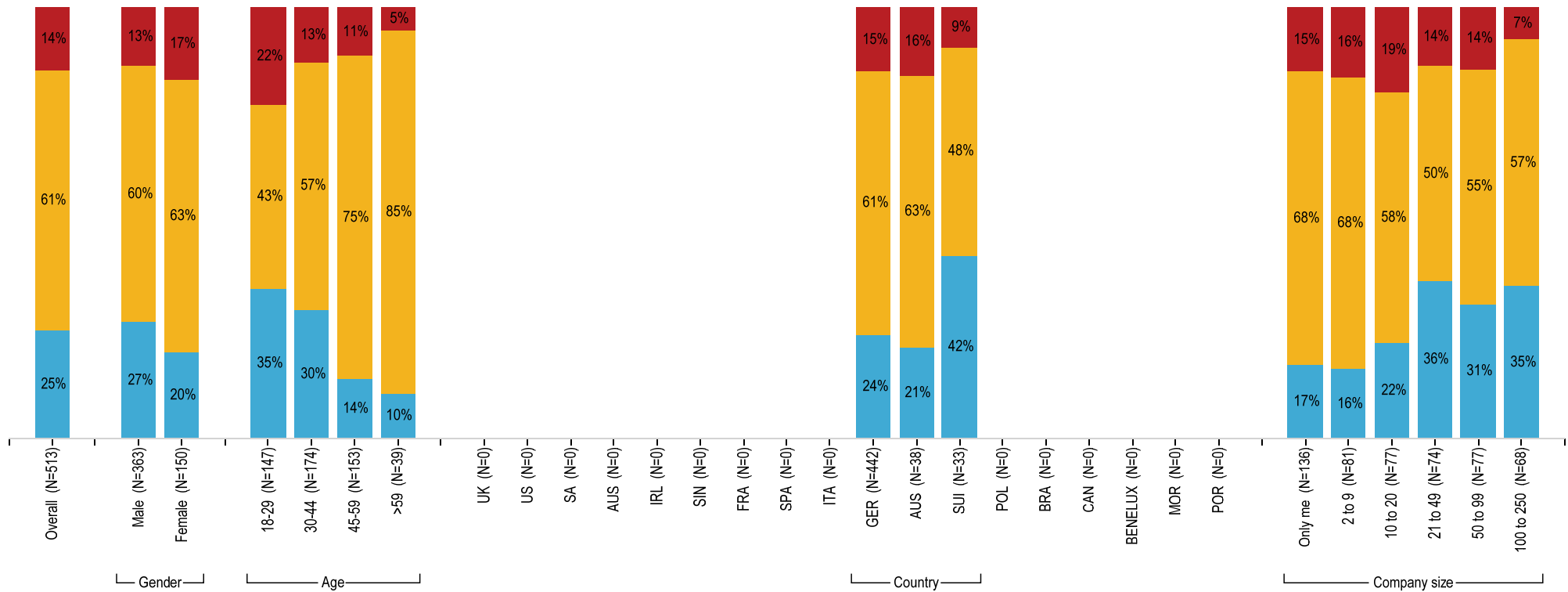
Do you feel SMBs are fairly represented in your country's political decision-making?

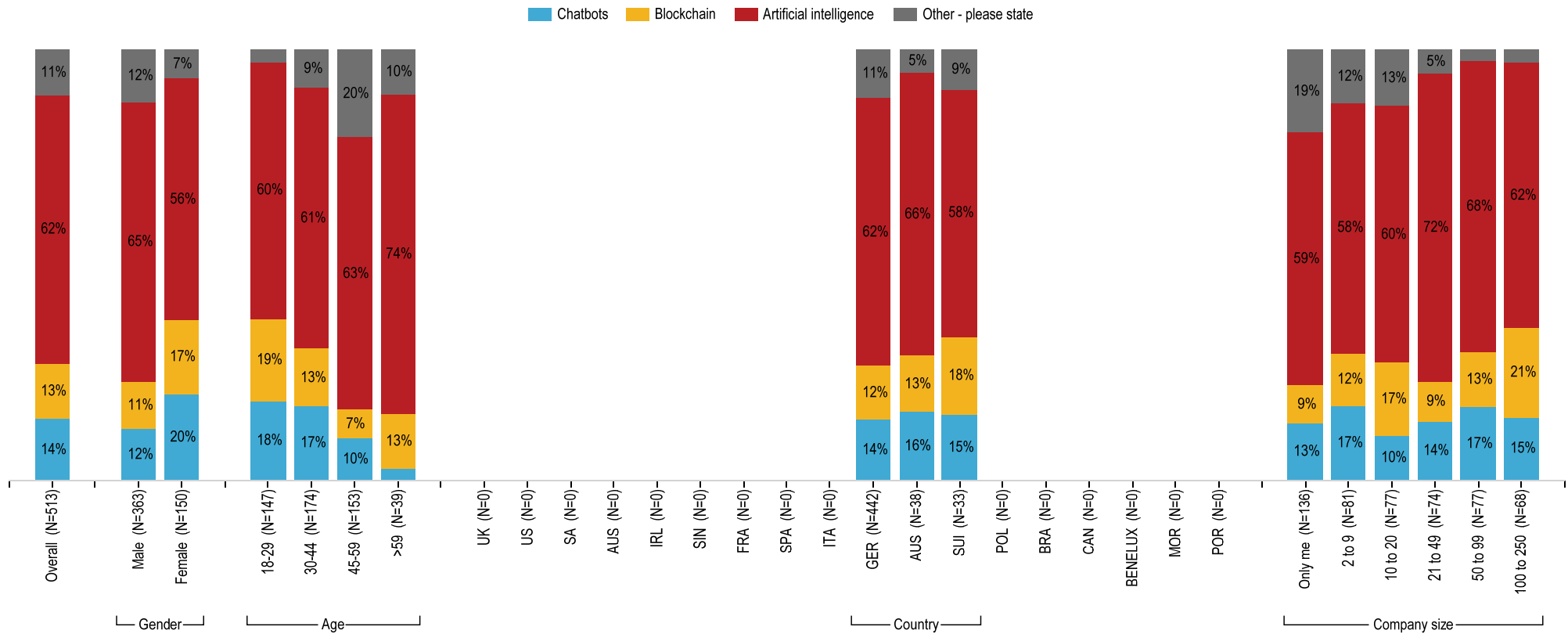
